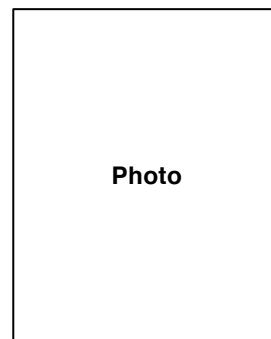

## **SPECIAL CONDITIONS**

### Missing prerequisite

In case of failure to an examination required for the admission of the student, the application may be cancelled free of charge if the school is informed by registered letter within 8 days of the publication of results. A copy of the results must be attached to the registered letter. In the case of deferment, these conditions will not apply, no refunds will be granted.

### Visa refusal

In case where the Visa is refused, the application may be cancelled free of charge if the school is informed by registered letter within 8 days of the official notification.

As an exception due to the administrative costs generated by EBS Genève/CREA INSEEC U. for the Visa application, any student who has obtained a Visa to study in Switzerland via the registration documents provided by our school will not be entitled to any refund in case of cancellation, regardless of the date of the request or the reason.

### Termination clauses

In the event of being unable to continue training for objective reasons or relating to his/her person, the student will be allowed to terminate the contract he/she has with EBS Genève/CREA INSEEC U..

In case of termination at the wrong time, particularly in the course of the semester, the student must pay the tuition fees for the semester in progress.

## **4. PARTIAL OR TOTAL INTERRUPTION OF THE PROGRAM**

Any unauthorized absence of the student for more than four consecutive weeks will be considered by the school as a definitive termination of the enrolment. In case of a payment method in instalments, the total due costs will must be paid immediately.

In case of contract termination, EBS Genève/CREA INSEEC U. will immediately inform the Office Cantonal de la Population et des Migration accordingly.

## **5. INTERNSHIP**

Students benefit from internship agreements for 5 months minimum and up to 8 months maximum within the same company. The search for an internship falls under the active responsibility of students, with ongoing support from the "Career Center" at EBS Genève/CREA INSEEC U.. No internship agreement can be issued by EBS Genève/CREA INSEEC U. if the student has not yet ended the Master 2 course.

## **“International Masters” admission regulations**

*Article 1:* The candidate can obtain the admission contract either on the school’s website, during a private meeting or during an information session.

*Article 2:* The candidate must fill in the admission contract in order to attend the evaluation interview. He/she will be advised of the date via email. If the candidate is unable to attend, he/she must contact EBS Genève/CREA INSEEC U. immediately. If the student fails to show up at the evaluation interview, the enrolment fees are not reimbursed.

*Article 3:* To receive the Master’s degree at the end of the course the candidate must hold a Bachelor degree or a qualification recognized as equivalent.

*Article 4:* The admission contract and its attachments must be sent by the deadline stipulated in order to guarantee access to the relevant course session. The entrance interview will only be deemed approved by the payment of the enrolment fee.

*Article 5:* The decision following the evaluation interview is communicated to the candidate within 20 working days. The decision is firm and irrevocable. In case of refusal, the enrolment fees are refunded within 4 weeks.

*Article 6:* The candidate can be admitted without conditions, or under the following conditions:

- fulfil a missing prerequisite
- attend another evaluation interview
- have an interview with another member of management

*Article 7:* A confirmed student who decides to cancel his enrolment, he must communicate his decision by a registered letter sent to EBS Genève/CREA INSEEC U. The conditions for a cancellation of registration are mentioned in the admission contract.

*Article 8:* If a student notices an orientation error in his Master’s program choice, a change can only be made under the following conditions, within 2 weeks after the start of the course:

The student must present clear reasons to the management of the Master course he/she wants to join.

The change may be approved provided that the occupancy rate of the requested Master allows it.

*Article 9:* In the event of postponement of the admission contract, the student agrees to follow the process and to pay the due amount.

*Article 10:* If a student repeats a year, the extra academic year will not be invoiced (apart from travel costs). The student is required to continue paying tuition fees according to the methods and due dates indicated in the admission contract signed by the different parties. The student will therefore have paid the entire tuition fee amount a year before the end of his/her course.

*Article 11:* With regards to the tuition fees, the student undertakes to be up to date in his payments before submitting his/her Master Thesis. The Diploma will be delivered to the student only once all tuition fees have been paid.

*Article 12:* Any student who takes steps to apply for a scholarship must read and sign EBS Genève/CREA INSEEC U.’s “scholarship application” document. The relevant instructions must be strictly adhered to. EBS Genève/CREA INSEEC U. may, without being obliged to, help the student in this process.

*Article 13:* All disputes are handled by EBS Genève/CREA INSEEC U.’s legal department and no right of appeal is possible regarding the admission process.

*Article 14:* With regards to the current Covid19 situation, EBS Genève/CREA INSEEC U. reserves the right to switch some or all of the courses to online sessions, if the health measures require it and/or if the students’ and staff’s security can’t be ensured.
