# V Enrolment

I hereby confirm my enrolment in the 2022-2025 training course at EBS Genève/CREA the total tuition fees amounting to CHF 49'500.-.

This amount also includes the costs of a MacBook Pro computer and graphics softwares for the 3 years of the Bachelor course.

#### **Additional costs**

Following costs are to be paid and are not included in the tuition fees:

- The enrolment fee of CHF 500.- for setting up the file. Once the enrolment is confirmed, CHF 500.- is payable for the file application. This amount is not refunded if the candidate withdraws or does not attend the entrance examination. However, if the candidate is not selected, the enrolment fee is refunded.
- Per year: CHF 60.- for computer insurance for theft and loss of the MacBook Pro (according to the terms of applicable regulations).
- Year 3 Semester at the London Campus: the travel et accommodation are additional.

#### Optional study trip

The above-mentioned tuition fees do not include costs related to the optional study trip, subject to actual organization by EBS Genève/CREA and subject to variations notably in relation to the destination of the trip and how it is arranged:

• Year 2 : Study trip to San Francisco, a campus of the OMNES Education group, at an estimated cost of CHF 1'500.-. If the student does not go on the study trip, an additional 1 month of the 2nd internship is required. If the study trip is cancelled, payment will not be required.

EBS Genève/CREA reserves the right to cancel the optional study trip if not enough students take part.

#### VII Withdrawal clause

#### Year 1 (2022/2023)

If the student withdraws during the period 15.03.22 to 16.10.22: the amount for the 1st term of year 1, i.e. CHF 4'125.-, is due.

If the student withdraws during the period 17.10.22 to 31.12.22: the amount for the 1st and 2nd terms of year 1, i.e. CHF 8'250.-, is due.

This clause is also valid if the student does not attend the first day when classes resume.

If the student withdraws during the period 01.01.23 to 30.06.23: the amount for the 3rd and 4th terms of year 1, i.e. CHF 8'250.-, is due (and the sums due for the 1st and 2nd terms remain due and payable to EBS Genève/CREA).

#### Year 2 (2023/2024)

If the student withdraws during the period 01.07.23 to 31.12.23: the amount for the 1st and 2nd terms of year 2, i.e. CHF 8'250.-, is due (and the sums due for year 1 remain due and payable to EBS Genève/CREA).

If the student withdraws during the period 01.01.24 to 30.06.24: the amount for the 3rd and 4th terms of year 2, i.e. CHF 8'250.-, is due (and the sums due for year 1 and the 1st and 2nd terms of year 2 remain due and payable to EBS Genève/CREA).

#### Year 3 (2024/2025)

If the student withdraws during the period 01.07.24 to 31.12.24: the amount for the 1st and 2nd terms of year 3, i.e. CHF 8'250.-, is due (and the sums due for year 1 and year 2 remain due and payable to EBS Genève/CREA).

If the student withdraws during the period 01.01.25 to 30.06.25: the amount for the 3rd and 4th terms of year 3, i.e. CHF 8'250.-, is due (and the sums due for year 1, year 2 and the 1st and 2nd terms of year 3 remain due and payable to EBS Genève/CREA).

Important: Any withdrawal, in accordance with the above, must be formally notified to EBS Genève/CREA by registered letter. Notification by e-mail is neither permitted nor valid.

#### VIII Late payment

In the event of late payment of any of the sums due under the admission contract and related documents, the student shall automatically be in default, with no notification required from EBS Genève/CREA. Depending on the situation, EBS Genève/CREA may send reminder(s), without questioning the payability of the amounts and/or the default. In addition, where applicable, after the third (registered letter) reminder, the total balance of the fees (for the current year, with previous instalments remaining due and payable to EBS Genève/CREA shall automatically be payable with immediate effect.

Non-payment of any of the instalments for the current fees may result in (i) temporary suspension from the course and/or (ii) termination of the admission contract by EBS Genève/CREA. However, all amounts due by the student remain payable.

In particular, in the event of a significant delay in payment, EBS Genève/CREA may require payment of any tuition fees before (i) classes resume, including when moving from one year to the next and/or (ii) submission of the Bachelor Thesis.

More specifically in relation to the Bachelor Thesis, if the student is not up to date with payment instalments and EBS Genève/CREA requires that the situation be sorted out, but the student does not comply, then the Bachelor Thesis shall be deferred to the following year (only one deferral possible). During this period, while waiting for submission of the deferred Bachelor Thesis as described above, the student will not receive any education. The submission of the Bachelor Thesis that has already been deferred to the following year cannot be deferred again. It would be deemed a definitive fail for the Bachelor program if the submission of the (already deferred) Bachelor Thesis cannot take place the following year due to late payment.

In all cases, the awarding of the Bachelor's degree (if applicable, the Diploma) is subject to payment of all tuition fees.

If the student is in default, EBS Genève/CREA reserves the right to recover any sums due by legal means, without 5 prior notice. The related costs will be charged to the student.

#### IX Situation in the event of a fail

If the student fails in the Bachelor program (with or without repeating a year), there shall be no refund or reduction of tuition fees. Similarly, if the student informs EBS Genève/CREA that they wish to stop the current Bachelor program, there shall be no refund or reduction of tuition fees and the provisions of this contract shall apply.

#### X Extraordinary circumstances

If the student, through no fault of their own, finds themself in a situation of such seriousness that continuing the course is not possible (in other words, an extraordinary circumstance), the student shall contact EBS Genève/CREA immediately in order to (i) explain in detail the relevant reasons and circumstances, in writing or in any other form acceptable to EBS Genève/CREA and (ii) provide their own assessment of the anticipated duration of the extraordinary circumstance.

EBS Genève/CREA will review the extraordinary circumstance and do all that it can to offer the student any options that may be acceptable given the circumstances.

# XI In the event of failure to obtain the university entrance qualification (maturité), school leaving certificate (baccalauréat) or equivalent

If the candidate/student passes their entrance examination and is in the final year at a lower or upper secondary school establishment (Gymnase, Collège or Lycée) or equivalent (as determined by EBS Genève/CREA) they may be admitted subject to obtaining their university entrance qualification, school leaving certificate or equivalent.

If the relevant diploma is not obtained, the candidate/student shall immediately inform EBS Genève/CREA of the situation, at the latest within the time limit set and in the form prescribed by EBS Genève/CREA for this purpose (by means of any communication used in this regard). In these circumstances, two solutions are possible:

- 1) The candidate/student has the possibility of deferring their enrolment at EBS Genève/CREA to the following year, without having to re-sit the entrance examination. Opting for this solution means that the candidate/student must:
  - Submit a copy of their grades sheet confirming their fail.
  - Complete a new admission contract for the following session (2023-2026 session), when this becomes available (from November 2022).
  - Pay the 1st term's tuition fees of CHF 4'125.- by 30.09.2022. This amount will be credited against future tuition fees.
  - The provisions of the new admission contract, for the following session, shall apply, with it however being specifically agreed that the amount applicable for the 1st term's tuition fees (above, subject to adjustment by EBS Genève/CREA) shall remain payable to EBS Genève/CREA in all cases.
- 2) The candidate/student has the possibility of starting at EBS Genève/CREA If the candidate/student does not want to repeat their year in order to obtain the university entrance qualification, school leaving certificate or equivalent, they still have the option of beginning the Bachelor at EBS Genève/CREA, subject to acceptance. Regarding this, the provisions of Article 3 of the Bachelor admission regulations provide useful additional information.

Any candidate/student who does not wish to start at EBS Genève/CREA for the Bachelor course and who prefers to continue their studies for the relevant university entrance qualification, school leaving certificate or equivalent, will be reimbursed for any tuition fees already paid to EBS Genève/CREA, with the exception of the enrolment fee of CHF 500.-, which will remain with EBS Genève/CREA. For this, the candidate/student must submit to EBS Genève/CREA a copy of (i) their grades sheet and (ii) any document establishing the continuation of the relevant studies.

#### XII Deferral of the admission contract

If the candidate/student wishes to defer the admission contract, they may apply to EBS Genève/CREA to have their enrolment at EBS Genève/CREA deferred to the following year. To do so, the candidate/student must make the deferral request by 30 June 2022 at the latest (this request can thus be made only prior to year 1) in accordance with the following:

- Send a registered letter to EBS Genève/CREA requesting deferral of admission.
- Fill in a new admission contract for the following session (2023-2026 session) when this is available (from November 2022).
- Pay the 1st term's tuition fees of CHF 4'125.- by 30.09.2022. This amount will be credited against future school fees.
- The provisions of the new admission contract, for the following session, shall apply, with it however being specifically agreed that the amount applicable for the 1st term's tuition fees (above, subject to adjustment by EBS Genève/CREA) shall remain with EBS Genève/CREA in all cases.

#### XIII Internship

The search for an internship falls under the active responsibility of students, but with ongoing support from the "Career Center & Businesses Department" at EBS Genève/CREA.

No internship agreement can be issued by EBS Genève/CREA if the student has not yet started the course, i.e. the first day when classes resume.

Two mandatory internships must be completed. An internship of 4 to 12 weeks at the end of the  $1^{st}$  year of the Bachelor. The  $2^{nd}$  internship of 6 to 8 months must be carried out during the  $3^{rd}$  year of the Bachelor.

In case of failure of the Bachelor Thesis, the student can't benefit form an additional internship agreement, if the mandatory internship period has been already validated.

#### **XIV** Entrance examination

Following approval of the admission contract and related file by the EBS Genève/CREA management, the candidate receives instructions for the entrance examination, which can take place in person or remotely.

#### **XVI** Final provisions

The Bachelor admission regulations are given to the candidate/student and are applicable.

EBS Genève / CREA reserves the right to cancel the Bachelor program if there are not enough students taking part.

The candidate/student's enrolment becomes binding and final as soon as the admission contract is countersigned by EBS Genève/CREA.

The candidate/student undertakes to comply with the regulations in force at EBS Genève/CREA. These will be communicated at a later date.

The relationship between EBS Genève/CREA and the candidate/student, in particular those stemming from this admission contract, falls under Swiss (national) law. In the event of a dispute, the ordinary courts of the Canton of Geneva shall have exclusive jurisdiction, subject to any appeal to the Federal Court.

#### "Bachelor" admission regulations

Article 1: You can obtain the admission contract either on the school's website, during a private meeting or during an information session.

Article 2 : The candidate must fill in the admission contract in order to attend the entrance examination. He/she will be advised of the date in the contract. If the candidate is unable to attend, he/she must contact EBS Genève/CREA immediately. If the student fails to show up at the entrance examination, the enrolment fees are not reimbursed.

*Article 3 :* The candidate must meet the following admission conditions in order to receive the Bachelor degree at the end of the course: (1) be between 18 and 25 years of age at the start of the course, (2) hold a diploma of secondary school studies II or equivalent by EBS Genève/CREA, (3) passed the entrance exam. There are special admission conditions for candidates without a diploma of secondary school studies II who have demonstrated real talent during the entrance examination. These students will receive a Diploma except in cases where they have an overall average of 5.

*Article 4 :* The admission contract and its attachments must be sent by the deadline stipulated in order to guarantee access to the relevant course. Sitting the entrance examination is deemed approved following payment of the enrolment fee.

Article 5 : For candidates who are minors at the time of enrolment, the admission contract must be signed by a parent or legal guardian.

Article 6: The results of the entrance examination are communicated to the candidate within 20 working days. The decision of the jury is definitive and irrevocable. In the event of rejection, the enrolment fees are reimbursed within 4 weeks.

Article 7 : The candidate can be admitted without conditions, or under the following conditions:

- fulfil a missing prerequisite

- re-sit part or all of the entrance examination and have an interview with a new jury

*Article 8 :* A confirmed student who decides to cancel his or her enrolment must communicate his or her decision by a registered letter sent to EBS Genève/CREA. The conditions for a cancellation of registration are mentioned in the admission contract.

Article 9: If a student notices an error in the course program in terms of his/her choice of Bachelor, a change can only be made under the following conditions, within 2 weeks of the course starting :

- present clear reasons to the management of the Bachelor he/she wants to enroll in

- pass the entrance examination for the Bachelor he/she wants to get into

The change may be approved provided there are enough students in the preferred Bachelor course.

Article 10 : In case of deferral of the admission contract, the student engage himself/herself to respect the adjustment procedure and pay the tuition fees.

*Article 11* : If a student repeats a year, the extra academic year will not be invoiced (apart from travel costs). The student is required to continue paying tuition fees according to the methods and due dates indicated in the admission contract signed by the different parties. The student will therefore have paid the entire tuition fee amount a year before the end of his/her course.

Article 12 : The student benefits from a MacBook Pro computer included in the tuition fees. At the end of the 3 years course and after having paid all tuition fees, the computer provided to the student becomes the student's property. If the student decides to leave EBS Genève/CREA during the course, he/she must return the computer. He/she can also purchase the computer on a prorata basis of the balance due.

Article 13: The student undertakes to settle all the tuition fees when presenting his Bachelor Thesis. The Diploma will be given to the student only once all tuition fees have been paid.

Article 14 : Any student who takes steps to apply for a scholarship must read and sign EBS Genève/CREA's "scholarship application" document. The relevant instructions must be strictly adhered to. EBS Genève/CREA may, without being obliged to, help the student in this process. There is no guarantee given by EBS Genève/CREA that the student will obtain a scholarship.

Article 15 : All disputes are handled by EBS Genève/CREA's legal department and no right of appeal is possible regarding the admission process.

Article 16: Given the Covid-19 situation, EBS Genève/CREA reserves the right to switch some or all courses to online format, if the sanitary restrictions require it and/or when the students' security can't be ensured anymore.
