# **IV** Enrolment

I hereby confirm my enrolment in the 2020-2023 training course at EBS Genève/CREA INSEEC U. the total tuition fees amounting to CHF 48'000.-.

This amount also includes the costs of a MacBook Pro computer and graphics softwares for the 3 years of the Bachelor course.

The following are not included in the tuition fees :

- The enrolment fee of CHF 500.- for setting up the file\*.
- Theft and loss computer insurance for the MacBook Pro amounting to CHF 60.- per year.
- Access to the Learning 7 platform and preparing for and going through the certification process, CHF 100.-.
- The costs of accommodation and the travel in London are in charge of the student .
- The financial contribution to the international study trip (for example: San Francisco) in the amount of CHF 1'200.-. In case of non-participation in a study trip, one additional month during the second mandatory international internship will be required (the third year) or one month at the end of the second year (optional internship from 4 to 8 weeks).

\* When enrolling, an amount of CHF 500.- must be paid for setting up the file.

This amount will not be reimbursed in the event of withdrawal or if the candidate fails to show up at the entrance examination. However, if the candidate is not selected, this enrolment amount will be reimbursed. The payment is to be made to the following account :

# **Cancellation of registration :**

#### Year 1 (2020/2021)

Cancellations received between the 30.06.20 to 11.10.20 : the amount of the 1st quarter of Year 1, so CHF 4'000.-, must be paid.

Cancellations received between the 12.10.20 to 31.12.20: the amount of the 1st and 2 nd quarters of Year 1, so CHF 8'000.-, must be paid.

This clause is also applicable if the person enrolled does not turn up on the day the course resumes.

Cancellations received between the 01.01.21 to 30.06.21 : the amount of the 3'td and 4th quarters of Year 1, so CHF 8'000.-, must be paid.

#### Year 2 (2021/2022)

Cancellations received between the 01.07.21 to 31.12.21 : the amount of the 1st and 2nd quarters of Year 2, so CHF 8'000.-, must be paid.

Cancellations received between the 01.01.22 to 30.06.22 : the amount of the 3td and 4th quarters of Year 2, so CHF 8'000.-, must be paid.

#### Year 3 (2022/2023)

Cancellations received between the 01.07.22 to 31.12.22 : the amount of the 1st and 2nd quarters of Year 3, so CHF 8'000.-, must be paid.

Cancellations received between the 01.01.23 to 30.06.23 : the amount of the 3td and 4th quarters of Year 3, so CHF 8'000.-, must be paid.

# Important : Termination of this admission contract, by either party, must be formally communicated to the other by a registered letter. Informing via email is not allowed nor valid.





#### **Payment failure**

The failure to pay one instalment by the due date, based on the student's payment method choice, and after the 3rd reminder (registered letter), the outstanding balance of the tuition fees will be automatically due without delay. EBS Genève/CREA INSEEC U. could initiate a legal procedure to recover the outstanding balance without prior notice.

# Termination

In the event of being unable to continue training for objective reasons or relating to his/her person, the student will be allowed to terminate the contract he/she has with CREA INSEEC U.

In case of termination at the wrong time, particularly in the course of the semester, the student must pay the tuition fees for the semester in progress.

# Failing to obtain a maturité, baccalauréat or equivalent

Any student who passes his/her entrance examination and is in the final year at a lower or upper secondary school establishment (*Gymnase, Collège or Lycée*) or equivalent, will be required to first obtain his/her maturité, baccalauréat or equivalent.

If the diploma is not obtained, there are two solutions available :

- 1) The student has the option of postponing his/her enrolment at EBS Genève/CREA INSEEC U. to the following year, without having to re-sit the entrance examination. To do so, the student must:
  - Provide a copy of his/her academic record showing the final marks and confirming the fail.
  - Complete a new admission contract form for the following course (2021-2024 course), when this becomes available (as of October 2020).
  - Pay the 1st term's tuition fees of CHF 4'000.- by 30.09.2020.
  - This amount will be credited against the tuition costs to pay.
  - The new admission contract for the next year be faith.
- 2) The student has the option of joining EBS Genève/CREA INSEEC U.

If the student does not want to repeat his/her year in order to obtain the maturité, baccalauréat or equivalent, he/she still has the option of beginning the Bachelor at EBS Genève/CREA INSEEC U. Please refer to Article 3 of the "Bachelor" admission regulations on page 8.

Any student who does not want to join EBS Genève/CREA INSEEC U. and continue studies, will be reimbursed the amount already paid to EBS Genève/CREA INSEEC U. with the exception of the enrolment fee of CHF 500.-. The student will need to provide a copy of his/her academic record showing the final marks and confirming the fail.

#### Postponement of admission contract

In event of deferral of admission contract, the student shall have the possibility to postpone his/her enrolment to EBS Genève/CREA INSEEC U. for the next year. To do so, the student must:

- Send a registered letter to announce its wish to deferral its contract
- Complete a new admission contract form for the following course (2021-2024 course), when this becomes available (as of October 2020).
- Pay the 1st term's tuition fees of CHF 4'000.- by 30.09.2020.
- This amount will be credited against the tuition costs to pay.
- The new admission contract for the next year be faith.

#### **VI** Internship

The search for an internship falls under the active responsibility of students, but with ongoing support from the "Internships and Businesses Department" at EBS Genève/CREA INSEEC U.

No internship agreement can be issued by EBS Genève/CREA INSEEC U. if the student has not yet started the course, i.e. the first day when classes resume. Below the schedule for the internships :

- 1 mandatory internships from 4 to 8 weeks must be realized during the first year.

- 1 optional internships from 4 to 8 weeks could be realized during the second year.

- 1 mandatory international internship of 6 months must be realized during the third year.

Throughout the period of their studies students benefit from internship agreements of up to 8 months maximum within the same company.

#### VII Entrance examination

After approval of the application form by EBS Genève/CREA INSEEC U.'s management, the candidate receives instructions for his/her entrance examination.

The entrance examination is held on the premises of EBS Genève/CREA INSEEC U. (date indicated below), lasts about 30 minutes and takes place in the presence of two experts, one of whom is a member of the school's management.

#### 1. Presentation of personal project (about 20 minutes)

This is a personal project carried out by the candidate based on a briefing (topic given) sent to the student within 5 days of EBS Genève/CREA INSEEC U. receiving the school enrolment form. The student has about 2 to 3 weeks to work on this project. The topic chosen and the related materials are described in the briefing.

# 2. Face-to-face interview (about 10 minutes)

Interview and discussion covering diverse subjects (motivation, general knowledge, personal talents, analytical skills, creativity and ability to express oneself).

The time of the oral evaluation will be confirmed by email.

The candidate's enrolment at EBS Genève/CREA INSEEC U. becomes final only after the admission process has been completed, including the entrance examination.

EBS Genève/CREA INSEEC U. reserves the right, in the event of insufficient numbers, to cancel the course.

In the event of a dispute, the parties shall refer to the courts of Geneva only (EBS Genève/CREA INSEEC U. headquarters).

#### "Bachelor" admission regulations

Article 1: You can obtain the admission contract either on the school's website, during a private meeting or during an information session.

Article 2: The candidate must fill in the admission contract in order to attend the entrance examination. He/she will be advised of the date in the contract. If the candidate is unable to attend, he/she must contact EBS Genève/CREA INSEEC U. immediately. If the student fails to show up at the entrance examination, the enrolment fees are not reimbursed.

*Article 3 :* The candidate must meet the following admission conditions in order to receive the Bachelor degree at the end of the course: be between 18 and 25 years of age at the start of the course – hold a diploma of secondary school studies II or equivalent. There are special admission conditions for candidates without a diploma of secondary school studies II who have demonstrated real talent during the entrance examination. These students will receive a Diploma except in cases where they have an overall average of 5.

Article 4 : The admission contract and its attachments must be sent by the deadline stipulated in order to guarantee access to the relevant course. Sitting the entrance examination is deemed approved following payment of the enrolment fee.

Article 5 : For candidates who are minors at the time of enrolment, the admission contract must be signed by a parent or legal guardian.

Article 6 : The results of the entrance examination are communicated to the candidate within 20 working days. The decision of the jury is definitive and irrevocable. In the event of rejection, the enrolment fees are reimbursed within 4 weeks.

Article 7: The candidate can be admitted without conditions, or under the following conditions:

- fulfil a missing prerequisite

- re-sit part or all of the entrance examination and have an interview with a new jury

Article 8 : A confirmed student who decides to cancel his enrolment, he must communicate his decision by a registered letter sent to EBS Genève/CREA INSEEC U. The conditions for a cancellation of registration are mentioned in the admission contract.

Article 9: If a student notices an error in the course program in terms of his/her choice of Bachelor, a change can only be made under the following conditions, within 2 weeks of the course starting :

- present clear reasons to the management of the Bachelor he/she wants to enrol in

- pass the entrance examination for the Bachelor he/she wants to get into

The change may be approved provided there are enough students in the preferred Bachelor course.

Article 10 : In case of deferral of the admission contract, the student engage himself/herself to respect the adjustment procedure and pay the tuition fees.

Article 11 : If a student repeats a year, the extra academic year will not be invoiced (apart from travel costs). The student is required to continue paying tuition fees according to the methods and due dates indicated in the admission contract signed by the different parties. The student will therefore have paid the entire tuition fee amount a year before the end of his/her course.

*Article 12* : The semester at London during the first part of the third year is mandatory for all students. The price of course in London school are already included in the tuition fees. However the costs of accommodation and the travel in London are in charge of the student.

Article 13 : The student benefits from a MacBook Pro computer included in the tuition fees. At the end of the 3 years course and after having paid all tuition fees, the computer provided to the student becomes the student's property. If the student decides to leave EBS Genève/CREA INSEEC U. during the course, he/she must return the computer. He/she can also purchase the computer on a prorata basis of the balance due.

Article 14: The Diploma will be given to the student only once all tuition fees have been paid.

Article 15 : Any student who takes steps to apply for a scholarship must read and sign EBS Genève/CREA INSEEC U.'s "scholarship application" document. The relevant instructions must be strictly adhered to. EBS Genève/CREA INSEEC U. may, without being obliged to, help the student in this process. The student cannot be conditioned at the obtaining a scholarship.

Article 16 : All disputes are handled by EBS Genève/CREA INSEEC U.'s legal department and no right of appeal is possible regarding the the admission process.
